

NT KENO'S Friday FIVE! Terms and Conditions

- 1. A \$50 NT Keno voucher is won with a correct answer, as described in the terms and conditions below and exclusive to NT Keno, the Promoter.
- 2. By entering and/or participating in the promotion, each eligible participant agrees to abide by these terms and conditions.
- 3. The promotion commences on the 22 June 2020 and ends on the 17 July 2020.
- 4. Monday to Friday, each day, the hosts on Mix 104.9FM will draw out a number 1 to 80.
- 5. Friday listeners must call with the Monday, Tuesday, Wednesday, Thursday and Friday numbers that have been called out by the hosts to win the voucher.
- 6. The following are ineligible to enter this promotion:
 - i. Mindil Beach Casino Resort staff, of any capacity
 - ii. Spouses and/or de-facto spouses of the above listed staff
 - iii. Persons under the age of 18 years
 - iv. Any person who at the time of the promotion/draw is excluded under the relevant provisions of the Northern Territory Gaming Legislation
 - v. Any person who at the time of the promotion/draw is self-excluded from gaming venues in the Northern Territory
- 7. The NT Keno Radio promotion will be available to a caller on the Mix 104.9FM radio.
- 8. The caller is chosen at the discretion of Mix104.9 FM and each participant that is chosen has the opportunity to answer the promotional question to win the prize.
- 9. If the participant answers the question correctly, they will win a \$50 NT Keno ticket at their chosen NT Keno venue.
- 10. If the participant answers the question incorrectly they will not win any prize, however are able to reenter on other days.
- 11. When the first participant answers the question incorrectly the radio station will select a second caller who will have a chance to answer the same question.
- 12. Should the second caller answer the question incorrectly the radio station will select a third caller and so on, till the maximum callers answered is 5.
- 13. The winner must inform the hosts of the radio station their Full Name, Date of Birth and the NT Keno venue they wish to play their promotional \$50 NT Keno ticket.

- 14. The successful participant will have one week from the day of the question to attend the venue they nominated and claim their ticket. Should the winner not claim the ticket within 7 days the offer will expire.
- 15. The successful participant must present the venue with the voucher (Darwin City winners only) and proof of name and age that match the caller details before a ticket can be issued.
- 16. It is the responsibility of the venue to validate the winner's details including name, date of birth and confirming via the Multi-Venue Self Exclusion Register that person is not self-excluded from the venue.
- 17. The \$50 ticket can only be redeemed in one transaction and can not be used on Heads or Tails, all other tickets are eligible.
- 18. The ticket is not transferable or redeemable for cash. There are no alternative prizes offered and there will be no compensation payable if a prize winner is unable to claim their prize.
