### THE SPORTSBAR AND COOPERS VIP BETEASY DARWIN TRIPLE CROWN 2019 PROMOTION TERMS AND CONDITIONS

#### Promoter

Mindil Beach Casino Resort, Gilruth Avenue, The Gardens, Northern Territory, 0820

#### Entry Restrictions

Open only to NT residents aged 18 or over and who are able to take the prize in Darwin, 14<sup>th</sup> – 16<sup>th</sup> of June 2019.

The following are ineligible to enter this promotion:

- i. Mindil Beach Casino Resort staff, of any capacity
- ii. Spouses and/or de-facto spouses of Mindil Beach Casino Resort staff
- iii. Persons under the age of 18 years
- iv. Any person who at the time of the promotion/draw is excluded under the relevant provisions of the Northern Territory Gaming Legislation
- v. Any person who at the time of the promotion/draw is excluded from any area of Mindil Beach Casino Resort Darwin

#### Promotional Period

The promotional period commences at 10.30am (ACST) on 01/05/2019 and concludes 11.59pm (ACST) on 01/06/2019.

#### Venue

#### Entry Method

During the Competition Period, entrants must:

- a) purchase any Coopers product in The Sportsbar (Eligible Purchase) for on premise consumption to receive one (1) entry form (subject to entry form stocks remaining);
- b) To enter the draw the customer must write their first name, surname, telephone number and email legibly on the back of the entry ticket and place this in the entry box.

It is the ticket holder's responsibility to fill in their details on the entry ticket and to place the ticket(s) into the designated barrel. To accurately complete an entry ticket, the customer must include their full name (first and last name), address, email and contact number.
